I am writing regarding your request for information, which was received on 2 May 2019 about CCG Funding Support to Hospices.

*Please could you provide the following information*

1. *How many hospices do you allocate grant funding to as a CCG? (these may be within your geographical area or they provide services to your area)*

**3 hospices.**

2. *What grant funding ( £ 000's) have individual hospices been allocated in this financial year (2019/2020)?*

**Paid grants in 2019/20:**

- **Eden Valley Hospice = 610.8k (estimated 102k Drugs)**
- **Hospice at Home West Cumbria = 290.4k**
- **Hospice at Home Carlisle and North Lakeland = 283.6K**

3. *Is the grant funding for any hospice in the current year 2019/20 a change when compared to the previous year 2018/19?*

*No stayed the same*

**Eden Valley Hospice = increase of approx. 1% over 2018/19 grants**

**Hospice at Home West Cumbria = increase of approx. 1% over 2018/19 grants**

**Registered population is 325,137.**


