Request under the Freedom of Information (Scotland) Act 2002

I refer to your email of 22nd September 2014 in which you have requested the following information be provided to you.

- ***I would like copies of the CCTV footage obtained from George Square on Thursday and Friday last week.***

Community Safety Glasgow (CSG) is responding to your request in terms of the Freedom of Information (Scotland) Act 2002 and confirms that we no longer hold the information that you have requested. A Freedom of Information Response Sheet is enclosed with details of where the information may be found.

CSG accordingly feels that it has now complied with your request. However, if you are dissatisfied with the information CSG has provided in response to your request you are entitled to request CSG to review its response. Please note that for a review to take place you must:

- Address your request for the attention of the Acting Director at the :



You will receive notice of the results of the review within 20 working days of receipt of your request. The notice will state the decision reached by the reviewing officer as well as details of how to appeal to the Scottish Information Commissioner if you are still dissatisfied with CSG's response.

You must request an internal review by CSG before a complaint can be directed to the Scottish Information Commissioner.
