I request information (FOI type) about the Application Numbers and Titles of all the Funding Applications made by LSE to ESRC, between 01/12/2016 and 01/10/2018. Also, please indicate which applications were awarded funding.

Please note that redactions have been made to withhold personal information. Releasing the names of individuals concerned in the attached "Application ES/M010341/1" constitutes personal data under the Data Protection Act 2018. Section 40 (2) & (3) of the FOI Act provides an absolute exemption in disclosing personal data and therefore is not subject to a Public Interest Test.

Further redactions to "Application ES/M010341/1" have been made where information has been provided to UKRI in confidence and therefore cannot be released. Section 41 of the Freedom of Information (FOI) Act sets out an absolute exemption from the right to know where the information was provided to the public authority in confidence. Release of this information would amount to a breach of confidence. A Public Interest Test is not required to engage this exemption.

Section 41 has also been applied to "FOI request LSE applications" as we do not disclose grant titles for unfunded applications for the same reasons set out above. The titles of funded applications can be found on Gateway to Research by searching the reference numbers provided.

Public interest test in favor of withholding the information:

Releasing information of commercial interest is likely to prejudice the commercial interests and
activities of the Institutes and UKRI as the information was provided in confidence to UKRI and
releasing it is therefore likely to damage the possibility of ongoing relationships with this and other
Institutes.

UKRI has reached the view that, on balance, the public interest is better served by withholding this information under section 43(2) of the FOI Act.
