RE: Request for Information held by SWFRS

Your request ref: 282 1920 has been dealt with under the Freedom of Information Act 2000.

You asked us:

Does your service have a formal system that allows uniformed operational staff swap shifts. For example a firefighter who is due to work a Saturday can swap his work day with a firefighter who is rostered off?

if so, does your service record these swaps and keep a running tally of the swaps for the individuals? What happens when one resigns or retires. Does your service have a way of dealing with any positive or negative balances for these swaps. For example the swap mentioned above what would happen if either of them then resigned or retired before the "pay back of the swap". Would the firefighter who got Saturday off have his final pay reduced because he never paid his day off back to the other firefighter? Or if the firefighter who worked the extra shift then retired or resigned. Would he receive a days pay for working the Saturday and the Firefighter that got the day off have to work a day to pay back the day off he got?

Our response:

I can confirm we have a 'Stand-In Policy' whereby it allows station based personnel to swap their shifts. Attached is a copy for your information. Both individuals must have the relevant skill sets and they must not work 24 hours.

Stand-in requests are approved and monitored at station level by the relevant Station Commander. It is the individuals' responsibility to ensure they work back any stand-in shift they have received from a colleague.
