## Freedom of Information Request

I refer to your request for information dated 28 November 2019 under the Freedom of Information (Scotland) Act 2002 (the "**Act**").

## Your request

You requested the following information:

I would be grateful if you could tell me the number of tenants who reside in Rosemount Buildings Edinburgh who have had their tenancies changed from a Scottish Secure Tenancy to Short Scottish Secure Tenancy due continued anti social behaviour either by them, their visitors or a combination of tenant and visitor. I would like this information from 1 May 2019 to 28 November 2019 broken down by a. month b. result of anti social behaviour by tenant c. result of anti social behaviour by tenant and visitor

## Our response

I write to advise you that I have established that Dunedin Canmore Housing Association do not hold the information that you have requested. This is because Dunedin Canmore Housing Association has not converted any tenancies at Rosemount Buildings, Edinburgh from a Scottish Secure Tenancy to a Short Scottish Secure Tenancy during the time period specified above. This information is therefore exempt under Section 17 of the Act.

## Review and appeal

If you are dissatisfied with the way that the we have dealt with your request you are entitled to require that we review our decision. Please note that for a review to take place you must:

- Lodge a written request for a review within 40 working days of the date of this letter; and
- Include a correspondence address and a description of the original request and the reason why you are dissatisfied.
