#### 2013/521 - Chief Constable Motorcycle course

In response to your recent request for information regarding;

It has come to my attention that the Chief Constable of North Wales has recently "approved" a motorcycle course for himself. This obviously involves some expense to the force and thereby the public. It has also come to my attention that the Chief Constable acquired not one, but two sets of motorcycle clothing, again at the expense of the North wales police. Other than the fact he is a motorcyclist himself and would probably enjoy tearing round the countryside on a motorcycle in preference to a day's work, I would seriously question the operational requirement for him undertaking such a course. I would therefore ask the following questions;

### 1) Firstly, is it correct that he did in fact undertake such a course and, if so, what were the relevant dates/length of the course?

The Chief Constable has completed two courses, a standard motorcycle course and an advanced motorcycle course.

Every day the Chief Constable worked in the office or at home both before and after the course. Courses were conducted on the weekends where possible to minimise disruption to other commitments Mr Polin has to meet.

### 2) If the answer to 1 was "yes", what were the justifications of him taking the said course?

Mr Polin is focusing on becoming qualified to ride a police motorcycle to enable him to effectively participate in Operation Focus. Working alongside our officers, to engage with the motorcyclists and motorists who visit our Force area.

It has also assisted him with carrying out visits across the Force area (which he does frequently), visiting incidents whilst on patrol and attending meetings on occasion.

# 3) What were the cost implications of the course, to include the cost of the course itself and the Chief Constables wages whilst on the course?

The costs of the courses are as follows:

Advance Motorcycle Course	9	£3,523	
Bike Assessment	1	£370	

The costs of the courses are derived from the National Training Costing model methodology and include:

- Direct Costs Cost of Trainer, Fuel costs, etc.
- Indirect Costs/Overheads Covering costs such as Vehicle Costs (Depreciation, Repair & Maintenance), Administration costs, General Overheads etc.
