Thank you for your email that was received on 28th February 2012 requesting the following information:

Children seen in Private Law Proceedings

Please advise for the years ending 31-12-2008, 2009, 2010 and 2011 the numbers of Private Law Applications received by Region, how many proceeded to Allocation to a Family Court Adviser, how many of those proceeded to a Court Hearing, how many children were actually seen by either a Family Support Worker and / or FCA in order to ascertain their Wishes and Feelings.

Please note: Private law cases can also have a co-worker in addition to the lead practitioner.

Family Support Workers (FSWs): FSWs cannot be allocated as lead practitioners to private law cases, but can be allocated as a co-worker to a FCA. In rule 9.5 / 16.4 cases, if the judge in a case, where there is an appointed Children's Guardian, has the court's approval to the involvement of a FSW in the work, it is acceptable to allocate the FSW as a co-worker to the case. If the court's approval has not been obtained, the FSW should not be undertaking work on the case, nor should they be allocated in any way, including through CMS notes.

Please see table for FSW co-allocation below.

If you are unhappy with the decisions made in relation to your request, you may ask for an internal review to be undertaken.
