Thank you for your email dated 9 October 2020 where you requested information about children with detained parents

Request

In the past 5 years, how many children (under age 18 years, who are UK citizens or have leave to remain in UK) were placed in county care due to one or more parents being detained by the Home Office relating to their immigration status?

If relevant, how many of these children were reunited with parents after the parental detention

From our preliminary assessment, it is clear that we will not be able to answer your request without further clarification.

The Council requires further information in order to identify and locate the information you have asked for. In particular, it would be useful to know what you mean by county care

Once you have clarified your request, I will be able to begin to process your request. If I do not receive clarification within three months your request will be considered to have lapsed.
