Thank you for sending through the documentation relating to the proposals for the substation site at Chilling. That is most helpful. Assuming the elm is avoided removal of adjacent oaks and scrub might be beneficial as the elm is starting to get shaded out by taller trees. Presumably it will be needed, anyway, to go under the section of concrete road here which has been reinforced because of tunnelling damage caused. Ideally they should cross the

5c ... There may or may not be but I think removal of trees would actually be beneficial. The resulting grassland corridor would probably provide better bat foraging / invertebrate feeding areas than currently exist.
