Freedom of Information Request – Reference FOI 1339

I refer to your request under the Freedom of Information Act 2000, received on 27 October 2020.

Please accept my sincere apologies for the delay in responding to your request.

Set out below is the request you have made and our response to it.

REQUEST

"In your report titled 'Policing Sheffield's Trees Protests' it is stated at 7.5 that: "SYP made 25 arrests at tree protest sites between January and March 2018.

Whether charges are pursued is a matter for the Crown Prosecution Service."

Please provide any and all information associated with the statement in the report quoted above.

I am seeking to ascertain why there is such a glaring discrepancy between the constabulary's figure in the following document - https://www.southyorkshire.police.uk/media/4704/20191670-press-releases-publish.pdf and the figure included in your report and also clarify the origin of the information quoted in the report and of course its veracity.

RESPONSE

Section 1 of the Freedom of Information Act 2000 provides two distinct but related rights of access to information, which impose corresponding duties on public authorities. These are:

- Section 1(1)(a) the duty to inform the applicant whether or not information is held by the authority, and if so,
- Section 1(1)(b) the duty to communicate that information to the applicant.
