Hi Personal Data

An order should be forthcoming but seems to have been held up for some reason. In the meantime the attached maps show the areas of work this is to cover for your perusal.

Bacton RB2 – this is on the edge of the village. The route is bounded by garden fences on one side, an old flint wall on the other. Trees and bushes have grown up next to the flint wall. I don't want these removed as I don't want to disturb the wall itself but the overgrowth from the trees/bushes/brambles cut back. There are a number of fallen tree branches and trunks on the path that have been cut up but need moving to the side as best as you can. No significant clearance work to be undertaken on the garden fence sides.

Knapton RB5 – the path is between the hedge banks and this needs shrubs, blackthorn etc removing to widen it.

Knapton BR4 – this may be more overhanging vegetation as well that needs cutting back to allow for horse use. The route needs to be widened by removing side growth.

Paston RB10, Bacton RB9 and Knapton RB11 – the usual ones. Clearance of blackthorn to improve width at northern end of RB10 Paston continuing south from where you left off last year. Knapton RB11 blackthorn needs clearance. Widening encroaching brambles along full lengths on both routes.

All will need some sort of chainsaw work I suspect and the paths will need appropriate warning signage erected at each end of work sections.

Let me know once the order has come through and we'll arrange a time to meet up and look at the Knapton RB5/BR4 ones as I'm not too sure of the work here and would like to clarify in my own mind.
