# ITEM 1: DECLARATIONS OF INTEREST (CONFIDENTIAL ITEMS)

1. No interests were declared in relation to the items for discussion in the closed session of the meeting.

# **ITEM 2: MINUTES**

2. The minutes of the closed session of the 82<sup>nd</sup> SNH Board meeting, held on 11 February 2003, were agreed as a true record.

# ITEM 3: CURRENT ISSUES (CONFIDENTIAL ITEMS)

#### Relocation

3. The Chairman and Chief Executive were to meet Ross Finnie on 19 March to discuss relocation.

#### Kinloch Castle

4. Endemol Television Productions was planning a TV series on natural heritage assets in need of care and attention. It planned to include Kinloch Castle in the programme. There would be an ultimate winner which would be awarded a substantial amount of money. The series was scheduled for broadcasting in the Autumn.

# Health and Safety Executive (HSE) Investigation

5. SNH had replied to the improvement notices within the stated time limit. A presentation on the submission would be made on 31 March to a range of people, including representatives from the HSE. It was still not clear if a Fatal Accident Inquiry would take place.

### Areas Boards Appointments

 Following Nick Kempe's appointment to the Board, the West Areas Board had now appointed its reserve candidate, Ruth Tittensor, for a period of two years, commencing 1 April 2003.

### ITEM 4: THE REVIEW OF NATIONAL NATURE RESERVES

7. The paper asked the Board to decide the future of Loch Maree Islands National Nature Reserve which is currently on the orange list. The Board discussed the following points:

- the main doubt over the NNR had been that of surety of tenure.

  There were promising signs that a lease could now be negotiated;
- the NNR was likely to come under increased pressure for access.
   The proposed lease would need to consider new access arrangements .
- 8. The Board agreed that Loch Maree Islands should remain a National Nature Reserve, subject to the completion of a satisfactory lease.
