### **Freedom of Information (Scotland) Act 2002 - Section 8 (1) (b) name of applicant/pseudonym**

### **Appeal Information**

In terms of section 20 of the Freedom of Information (Scotland) Act 2002, if you are dissatisfied with the way in which your request was dealt with, you may request the Assessor review his actions and decisions taken within 40 working days of receipt of this Notice.

The request must be in writing stating a name and address for correspondence purposes and the reason for the dissatisfaction. The Reviewing Officer will carry out the Review within 20 working days of receipt of the request for a review and will write to inform you of the outcome. The reviewing officer is a senior official who has not been involved in the original decision.

If you are dissatisfied with the outcome following the Review of the decision you can make an application for determination by the Scottish Information Commissioner, within 6 months of receipt of notification. The Commissioner can then investigate the decision and determine whether you should receive the information requested in full or in part.
