Dear Alex,

Thank you for your email of 14 April 2016. We are pleased to provide you with the following information and quotation for carrying out an environmental noise assessment for a potential development on Spruce Hills Road, Waltham Forest.

In line with our usual approach we would propose to measure noise levels at the development site over at least one full 24 hour period in normal school term time. The measurements would be made using automatic data logging sound level meters provided safe and secure locations are available. Additional short sample measurements would be made at the start and/or end of the survey period if necessary in characterizing the noise exposure of the site.

The measurements would be targeted towards the main noise sources affecting the site that are identified during the site visit.

Once the survey has been fully completed, the data would be presented in a report, and the site assessed with reference to national planning guidance and any local planning guidance provided to us or easily found on the local authority's website. The report would include identifying the reductions in noise level necessary to meet current design standards for noise levels inside dwellings and the possible forms of the key elements (windows, ventilation and external walls) necessary to achieve the required sound insulation.

In order to carry out the assessment we would require details of the proposed development including a location plan showing the footprint of the development and floor plans for each level if available.

Our fee for the work above would be £1694.00 plus VAT. Any additional instructed work following submission of our report or otherwise outside the brief described would be charged for in addition according to the attached Schedule of Consultancy Rates.

The timing of the measurement survey would depend on when we are instructed, access arrangements and on suitable weather conditions (dry, with wind speeds below 5 m/s). 
