The plot of land that Circle now own is beginning to look very unsightly. Obviously, the college are still in the process of digging trenches

- this is taking an age - at the far end of the site, but Circle must surely now take responsibility for the general upkeep of the area. There is an abandoned trench with exposed piping adjacent to the turning circle at the top of the road. This is filling up with refuse. There is a manhole with cover removed next to my house and there are brambles growing from your site up the side of my house to a height of over 6ft. The whole site is in a sorry state compared with the well kept grounds we all used to enjoy. There is a lack of thought and responsibility on the part of Circle here which does not bode well for the future. Please address this situation this week.
