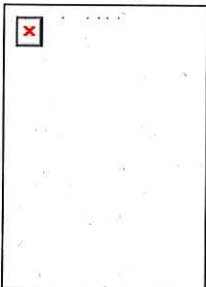

Transport Scotland are leading on the consultation on behalf of Marine Scotland for a joint approval by Scottish Ministers covering the Marine licences and the HRO.

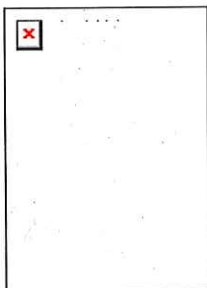
