

## What the MPs said

FOREST of Dean Tory MP Mark Harper has vowed to fight the decision to merge the force.

He claimed the move showed that the Government had ignored the views of local people and the county police force to press ahead with plans for a regional police force covering either the whole South West or two sub-regional forces.

He said: "These proposals are the worst outcome for the Forest of Dean.

"The Government has ignored the views of our police force despite telling us that we must listen to the police and take their advice."

He said the move would see the end of a police force under county control.

"The Government plans a massive regional force which will see the end of any local control of our policing. These new forces will take their instructions from ministers and civil servants in Whitehall."

And he said he feared the move would lead to the loss of resources in the county to larger connurbations such as Bristol.

"As well as this removal of local accountability, it is very likely that rural areas will start to see our resources taken away to police the large cities in the region," he added.

"We'll see fewer police on our streets despite having paid for them through high council tax. We will continue to collect signatures for our petition and we'll keep fighting to keep our policing local."

ECITY MP Parmjit Dhanda said he supported the move towards a regional police force, claiming it would lead to more officers on county streets.

"Frankly, I think people need to grow up a little bit and see this with a little bit of maturity," he said. "I agree with the minister who visited the city who said we need more officers on the street at a local level.

"I know from speaking to local police that although we have 1,000 constables, at any given time there will only be 25 on the street."

He said the merger would enable officers to get on with the job of policing and not other duties. It is definitely a step forward as the situation at the moment is not disgraceful, but it's not far from it.

"A bigger force will allow other job functions to be taken up by other officers outside our police area and get more officers out on the street.

"I want a bigger police force because I want a better police force.

"Too much of officers' time is taken up with other job functions.

"It's not good for me and it's not good enough for the people of Gloucester. They deserve better."

■ CHELTENHAM Liberal Democrat MP Martin Horwood said: "It's extraordinary I think I will be writing to the Home Secretary about this.

"It's so drastic a change. It would turn the police force from an accountable one to an anonymous regional entity.

"There would be no chance of councils and MPs having regular contact with chief constables as we've had up until now.

"They seem to have made a decision but I will challenge the Government to Justify

"I hope people will take the opportunity to support the Gloucestershire force because I still think that's the right option.

"Gloucestershire has a good record of level two policing I imagine they were the exception among county forces.

"I don't think the Government has looked at the evidence and has just done what it wanted to do in the first place."
