Kingmoor ERF – Discharge of Planning Conditions

I write to CCC Highways following the Notice of Planning Permission 1/18/9012. Cumbria County Council Highways is stated as a consultee with whom the Applicant is directed to make contact in regards to the Consented Development, Kingmoor Energy Recovery Facility, Kingmoor Park Industrial Estate, Land to the North of Kings Drive, Carlisle, CA6 4SE.

Under Section 184 of the Highways Act 1980, the County Council, as Highways Authority, must specify the works to be carried out. Only the Highway Authority or a contractor approved by the Highway Authority can carry out these works.

The consented scheme includes the construction of an access road which will connect to Kings Drive, Carlisle.

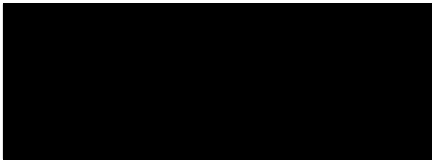
