REQUEST FOR INFORMATION: 2019-621600

We acknowledge your request for information seeking "a list of all complaints made to the office of the Presiding Officer concerning the conduct of MSPs under the whip of the Conservative party in Scotland and the Labour party in Scotland (and if the information is available, what steps were taken to resolve the issue) – please note, issues could also include allegations of sexual harassment."

Your request was received on 24 January 2019 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

Having considered your request, we require further information from you to identify the information you are seeking. Set out below is some background information explaining the nature of complaints that the Presiding Officer is and is not responsible for, in order to assist you in clarifying your request.

You might find it helpful if I explain that the Presiding Officer is only responsible for considering complaints made under the Code of Conduct for MSPs Section 8 (Engagement and Liaison with constituents) and some under Section 9 (Enforcement of Rules – Excluded Complaints, where these are investigated by the Presiding Officer).

Section 8 of the Code relates to the way in which MSPs are expected to deal with individual constituents' cases (for example, paragraph 8.1 provides that each MSP is expected to take on a constituent's case when approached, unless there are legitimate reasons for declining to do so); and how MSPs represent the basis on which they were elected or the area they serve (for example, describing

themselves as a constituency or regional MSP). The focus of the Presiding Officer's investigations in these cases is accordingly confined to whether or not an MSP has dealt with a constituent's case in accordance with section 8 or whether they have misrepresented the basis on which they were elected or the area they serve. Accordingly, the Presiding Officer has no locus to investigate any other complaints about conduct, including allegations of sexual harassment which you specifically refer to in your request.

Complaints in relation to the conduct of MSPs under the Code of Conduct for MSPs are initially investigated by the Commissioner for Ethical Standards in Public Life. Exceptions to this procedure are 'Excluded Complaints', which are referred to above and are set out in Section 9 of the Code. Broadly speaking, the role of the Commissioner is to independently establish the facts of a complaint. The Parliament's Standards, Procedures and Public Appointments Committee then considers whether it agrees with the Commissioner's findings and puts forward any proposed sanctions for consideration by the Parliament.

The Committee has received one complaint against an MSP regarding sexual harassment, which was investigated by the Commissioner who reported to the Committee on its findings in fact and conclusion. The Committee then proposed sanctions which were voted upon, and agreed, by the Parliament. This complaint was not against a member from either of the Conservative or Labour parties.
