Hi Victoria

I know we do have a line to take that covers the issues raised in some of them but there were 2 reasons I was not 100% happy to keep them in CST at the moment. The first one was that we are sending out a complex 'line to take' that Case Officers in CST would have no background knowledge to adapt if the person asked further questions, or called back to ask to clarify anything. The second reason was David Smith's comments. When we discussed it last I thought Dave was going to double check David Smith was happy with the line we were using before we went any further with these.

Obviously we can answer them here if we need to. It's just one of those things where it is clearly is an issue with media interest, possible developments with the stuff in Europe and I am worried that if we just start early on sending out a standard line we'll carry on like that with no way of knowing whether there are different things being raised or circumstances have changed.

If you and Dave are happy that this is a settled view that we are definitely happy to just send out from CST from now on then that's absolutely fine – we'll have any you have back and we'll deal with them here but I did want to be clear that is the best thing to do before we go ahead.


