Not sure who the right person is to contact but as it's in the Thames area I'm playing safe and contacting you both. There is a current application in for 119 dwellings to the south of Hungerford by Cala Homes which we are objecting to and have continuously objected to, but I just noticed from the list of consultees that NE have not been consulted.

It may be a site you are aware of as it has been floated about for a number of years as part of the West Berkshire Housing allocations Development Plan Document (DPD). It is allocated in this document for approx. 100 dwellings. The DPD went to examination in the summer but is yet unadopted with no comments yet provided by the Inspector. However at the examination the Inspector did raise concerns with this site due to the sensitive nature of the site, in particular the experience from within when using the PROW which provides expansive views up towards Combe Gibbet, Inkpen Hill and beyond, there was also an issue of a more appropriate alternative site to the south east of Hungerford which the Inspector considered had been dismissed on soft highways reasons.

The closing date for comments is Wednesday 11<sup>th</sup> January, so not long.
