I refer to your request where you asked:

"Dear Sirs

Please can you provide under the Freedom of Information Act a copy of any Call Off Contracts entered into by the Cabinet Office with Capita Business Services Limited, Brook Street (UK) Limited and Hays Specialist Recruitment Limited for the provision of services under the Contingent Labour ONE framework (RM960).

I am not seeking copies of the framework agreements entered into by Capita, Brook Street and Hays with Crown Commercial Services, or for any agreements relating to the provision of individual contractors. I am seeking the master call off contracts under the Contingent Labour ONE framework which allow the Cabinet Office to access the services of the three suppliers.

To avoid any concerns about Data Protection, please feel free to redact the Contact Reference, Account Manager and the Key Personnel from section 3.1.

I understand Government Digital Service is part of the Cabinet Office. If GDS has entered into any separate call off agreements with the three suppliers for the provision of services under Contingent Labour ONE, please can you include these within the scope of this request.

The Cabinet Office holds current call off contracts with Capita Business Services Limited and Brook Street (UK) Limited under the Contingent Labour One framework (RM960). Under section 22 of the FOI Act, it is Cabinet Office's intent to publish these contracts in the near future on the Contracts Finder website (https://www.contractsfinder.service.gov.uk)

Commercially sensitive and personal information will be redacted from these contracts.

Cabinet Office does not hold a call off contract with Hays Specialist Recruitment Limited under the Contingent Labour One framework (RM960).

The Government Digital Service has not entered into separate call off agreements with the suppliers for the provision of services under the Contingent Labour ONE framework.
