REQUEST FOR INFORMATION: Contract for Teleperformance - Clean Air Zone Programme/Vehicle Checker

Thank you for your request for information of 26 June 2020 about the contract for teleperformance - Clean Air Zone Programme/Vehicle checker. We have handled your request under the Freedom of Information Act 2000 (FOIA).

The information you requested and our response are detailed below:

Teleperformance - Clean Air Zone Programme/Vehicle checker

The details I require are:

- The original sourcing method for finding a supplier
- Any suppliers who applied for inclusion on any/contract and were not successful
- Actual contract values of each framework/contract
- Start date & duration of framework
- Is there an extension clause in the framework(s)/contract(s) and, if so, the duration of the extension?
- Has a decision been made yet on whether the framework(s)/contract(s) are being either extended or renewed?
- Who is the senior officer (outside of procurement) responsible for this contract?
