We refer to your request where you asked:

"Provision of Digital Live Support

Q1. When does the current contract expire? Are there additional contract extensions that may be taken?

Q2. Was the contract awarded via an Open tender, framework or direct award? If none of these how was the contract awarded?

Q3. Please provide a list of any suppliers who were unsuccessful during the tender process.

We are writing to advise you that following a search of our paper and electronic records, we have established that the information you requested is held by the Cabinet Office, including the Crown Commercial Service.

In response to your enquiry at question 1, I consider this information to be exempt from disclosure under Section 21(1) of the Freedom of Information Act. Section 21 exempts information if this information is reasonably accessible to the applicant by other means. Section 21 is an absolute exemption and the Crown Commercial Service is not required to consider whether the public interest favours disclosure of this information.

In response to your enquiry at question 2, I can confirm that the contract was awarded via G-Cloud 11. Additional information on G-Cloud 11 can be found here: https://www.crowncommercial.gov.uk/agreements/RM1557.11

In response to your enquiry at question 3, I am withholding the list of unsuccessful suppliers for this contract, as I believe that the disclosure of this information would be likely to prejudice the commercial interests of the unsuccessful suppliers and the Crown Commercial Service, consistent with the exemption at Section 43(2) of the Freedom of Information Act.

Section 43 is a 'qualified' exemption, which means that it is subject to a public interest test. In reaching the eventual decision, I have considered various factors of the public interest test, both in favour of disclosure and in withholding the requested information, which are discussed below:

Factors in favour of disclosing the requested information include:

- The Crown Commercial Service is committed to openness and transparency in its commercial activities, to allow public scrutiny and to demonstrate that public funds are being used in an efficient and effective way;
- Private sector companies engaging in commercial activities with the public sector must expect some information about those activities to be disclosed throughout the lifecycle of all commercial arrangements;

Factors in favour of withholding the requested information include:

- Disclosure may cause damage to an unsuccessful suppliers reputation, affecting
 the supplier's competitive position in their respective market and confidence that
 its customers, suppliers or investors may have in its commercial operations;
- Potential bidders for future contracts may be deterred from competing and sharing information with us, which would negatively impact upon the quality and quantity of Governments' supplier base;
- The Crown Commercial Service must retain commercial confidence of all parties

when they choose to engage in commercial activities with the department.

After weighing up the competing public interest considerations, I have determined that the balance of public interest is in favour of withholding this information requested under Section 43(2) of the FOIA.
