Thank you for your email dated 12 September 2015, in which you requested the following information from the Northern Ireland Office (NIO):

A letter from the Rt Hon Anna Soubry MP Minister of State for Small Business Industry and Enterprise was emailed by BIS's Cabinet Documents Officer to the First and Deputy First Minister N Ireland Executive on 24 July 2015. This email was copied to the Secretary of State for Northern Ireland.

Please let me have a copy of the covering email received from the Cabinet Documents Officer at 14:49 on 24 July 2015 which included the Secretary of States letter as an attachment

Your request has been handled under the Freedom of Information Act 2000 (FOIA).

I can confirm that the NIO holds information within the scope of your request; however the information is subject to exemption from disclosure under the terms of the Freedom of Information Act. Section 40 exempts personal information about a 'third party' (someone other than the requester), if revealing it would breach the terms of the Data Protection Act (DPA) 1998. The DPA prevents personal information from release if it would be unfair or at odds with the reason why it was collected, or where the subject had officially served notice that releasing it would cause them damage or distress. Please see a copy of the requested email at Annex A.
