Environmental Information Regulations 2004

Thank you for your request for information dated 12 May 2021 which the Council received by email. You have requested the following information:

Please provide a copy of the delegated officer report together with all consultation responses, neighbour consultation responses and file notes relating to planning application 21/00128/FUL - Erection of 1.8 metre high timber boundary fence structure including proposed coverage with green landscape treatment planting - Part Retrospective - Hodge Manor Hodge Lane Broadbottom.

I am pleased to advise that the Council can provide the information that you have requested attached. Please note some of the information has been redacted to remove third party data, which is exempt from disclosure under the following exception:

Regulation 12(3) prevents us disclosing personal data about individuals, unless it is disclosed in accordance with both regulation 13 and the Data Protection Act.

The Council has determined that the information relating to the third party should not be disclosed because disclosure would contravene one or more of the '7 key principles' that are set out under Article 5 of the General Data Protection Regulation (GDPR) which includes the principle that information should be 'processed lawfully, fairly and in a transparent manner in relation to individuals.' The term 'personal data' means data that relates to a living individual who can be identified.
