We are writing in respect of your recent application for the release of information held by the Authority.

Our answer:

Further we have not provided the information in the requested format as to do so would have constituted disproportionate effort within the meaning of the act, as such we have provided requests individually with associated documentation where appropriate.

Please note that this represents all requests that we have received except for any requests that were incorrectly categorised as FOIs which were in fact not (and consequently fall outside your request), it also excludes those already in the public domain and are available at whatdotheyknow.com.
