Thank you for your email of 12<sup>th</sup> December 2019, in which you requested the following information:

*I would like to draw your attention to FOI2019/00455 - if necessary I can re-open this request - but the documents in this FOI refer to a map or plan of owned land at Marden, this appears to be missing from the attachments however, will you please send me a copy of this showing NR owned land at Marden station."*

I have processed your request under the Environmental Information Regulations 2004 (EIR) as the information requested is environmental according to the definition in regulation 2(c) of the EIR.<sup>1</sup>

I can confirm we hold this information, please see attached 'FOI2019.01472 Marden Station' which shows the current ownership plan of Marden station.

While we include a copyright notice to go alongside every disclosure we make under the EIR, I would note in this instance that copyright belongs to the Ordnance Survey rather than Network Rail.<sup>2</sup>
