Diversion of Public Footpaths  
No. 31 in Fradley with Streethay Parish**

This Order is made by Lichfield District Council under Section 257 of the Town and Country Planning Act 1990, because it is satisfied that it is necessary to divert the footpath to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely; to facilitate part of a new employment development

**BY THIS ORDER:**

1. The footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be diverted as provided below.
2. There shall be created to the reasonable satisfaction of Lichfield District Council an alternative highway for use as a replacement for the said footpath as provided in Part II of the Schedule and shown by bold black dashes on the attached map.
3. The diversion of the footpath shall have effect on the date on which Lichfield District Council Certify that the terms of Article 2 above have been complied with.
4. The following works shall be carried out in relation to the highway described in Part II of the Schedule which is to reroute the footpath.
5. The applicant is hereby required to pay the cost of carrying out the said works.
6. Where immediately before the date on which a footpath is diverted there is apparatus under, in, on, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

**Schedule**

**Part I**

**Description of Site of Existing Way**

That a length of public footpath No.31 in the Parish of Fradley with Streethay commencing at point A on the attached plan grid reference E 414416, N 312261, running in a generally south westerly direction to point D grid reference E 414322, N 312237, on the attached plan.

## Part II

### Description of Site of New Way

The new route shall commence at point A on the plan grid reference E 414416, N 312261, then in a north westerly direction to point B on the plan grid reference E 414380, N 312317, then running in a south westerly direction to point C on the plan grid reference E 414309, N 312295, and then running in a southerly direction to point D grid reference E 414322, N 312237.

The path will be hard surfaced for the whole of its length with a prescribed width of 2 metres

This Order will also rectify a mapping discrepancy which will enable the network integrity to be maintained, this extends the co-ordinates from point E on the plan, grid reference E 414034, N 312033, to point F on the plan, grid reference E 414045, N 312007.

Part of the original footpath No.31 remains and has left a cul-de-sac effect. This Order will delete this remaining part of the footpath from point F on the plan, grid reference E 414045, N 312007, to point G on the plan, grid reference E 414089, N 312045.

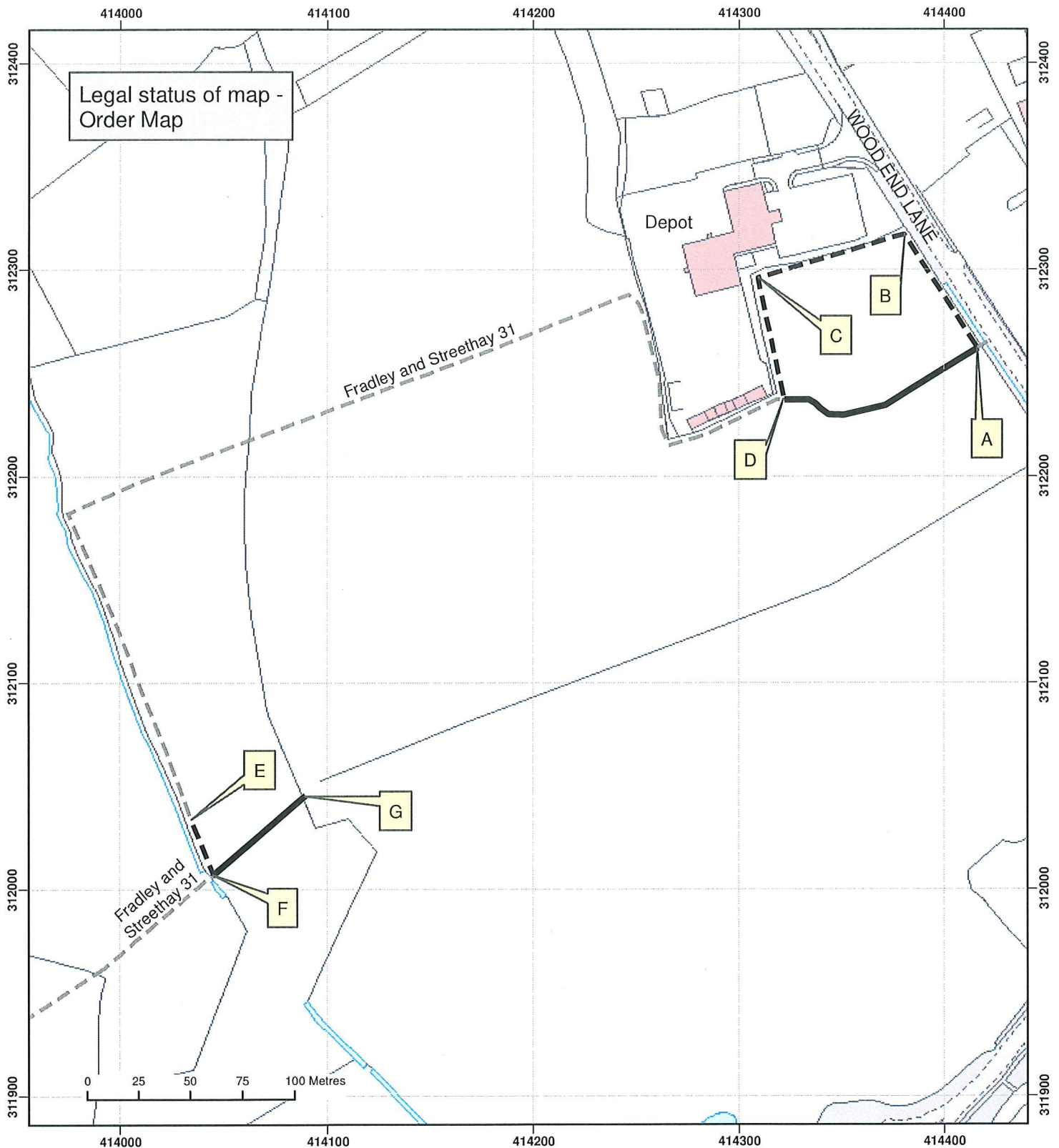
