

**HIGHWAYS ACT 1980, SECTION 119  
PUBLIC PATH DIVERSION ORDER**

**South Somerset District Council  
Public Footpath Y11/6 (Rushywood Farm, Haselbury Plucknett)  
Public Path Diversion Order 2019**

This Order is made by South Somerset District Council ("The Authority") under section 119 of the Highways Act 1980 because it appears to the authority that in the interests of the land owners it is expedient that the line of the footpath should be diverted.

FAW Bakers Kingston Farms Ltd of Leaze Farm, Haselbury Plucknett, Crewkerne, Somerset TA18 7RJ have agreed to defray any compensation which becomes payable in consequence to the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Somerset County Council have been consulted as required by Section 120(2) of the 1980 Act.

**BY THIS ORDER:**

1. The public right of way over land situated at Rushywood Farm, Haselbury Plucknett and shown by a continuous black line on the map attached to this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 14 days from the date of confirmation of this Order.
2. There shall be created to the reasonable satisfaction of Somerset County Council an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
3. The diversion of the footpath shall have effect on the date on which Somerset County Council certify the Order.
4. FAW Bakers Kingston Farms Ltd of Leaze Farm, Haselbury Plucknett, Crewkerne, Somerset TA18 7RJ are hereby required to pay the cost of carrying out the said works.
5. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.
6. This Order shall be known as the South Somerset District Council, Public Footpath Y11/6 & Y11/7 (Rushywood Farm, Haselbury Plucknett) Public Path Diversion Order 2019

**SCHEDULE  
PART 1**

Description of site of existing footpath path (F-G-H-J-K as indicated on the map)  
Path to be extinguished

The whole width of that part of **Public Footpath Y11/6** commencing at Grid Reference ST 46040 11273 (**Point F**) and running in a generally north easterly direction for a distance of approximately 183 metres to Grid Reference ST 46147 11424 (**Point G**) then running in a generally east north-easterly direction for a distance of approximately 211 metres, via Grid Reference ST 46313 11472 (**Point H**), to Grid Reference ST 46351 11474 (**Point J**). From here the footpath runs in an east south-easterly direction for approximately 126 metres to Grid Reference ST 46468 11428 (**Point K**).

Description of site of existing footpath path (K – Z as indicated on the map)  
Path to be extinguished

The whole width of that part of **Public Footpath Y11/7** commencing at Grid Reference ST 46468 11428 (**Point K**) and running in a generally south easterly direction for a distance of approximately 265m to Grid Reference ST 46595 11198 (**Point Z**).

**PART 2**

Description of site of alternative footpath (U-F as indicated on the map)  
Path to be created

Public Footpath, 2 metres wide, commencing at Grid Reference ST 45945 11246 (**Point U**) and running in an east north easterly direction for a distance of approximately 99 metres to Grid Reference ST 46040 11273 (**Point F**).

Description of site of alternative footpath (F-V-W- Y-Z as indicated on the map)  
Path to be created

Public Footpath, 2 metres wide, commencing at Grid Reference ST 46040 11273 (**Point F**) and running in a generally easterly direction for a distance of approximately 327 metres to Grid Reference ST 46371 12286 (**Point V**) then turning and running in a southerly direction adjacent to the farm road for a distance of approximately 75 metres to Grid Reference ST 46380 12213 (**Point W**). The Footpath then crosses the farm road and runs in an easterly direction for approximately 217 metres, via Grid Reference ST 46436 12217 (**Point Y**) to Grid Reference ST 46595 11198 (**Point Z**).

Description of site of alternative footpath (K- Y as indicated on the map)  
Path to be created

Public Footpath, 2 metres wide, commencing at Grid Reference ST 464668 11428 (**Point K**) and running in a southerly direction along the eastern side of the field boundary for a distance of approximately 214 metres to Grid Reference ST 46436 12217 (**Point Y**)
