# SOUTH SOMERSET DISTRICT COUNCIL PUBLIC FOOTPATH Y11/8 (RUSHYWOOD FARM) PUBLIC PATH DIVERSION ORDER 2019

This Order is made by South Somerset District Council ("The Authority") under section 119 of the Highways Act 1980 because it appears to the authority that in the interests of the land owners it is expedient that the line of the footpath should be diverted.

FAW Bakers Kingston Farms Ltd of Leaze Farm, Haselbury Plucknett, Crewkerne, Somerset TA18 7RJ have agreed to defray any compensation which becomes payable in consequence to the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Somerset County Council have been consulted as required by Section 120(2) of the 1980 Act.

#### BY THIS ORDER:

- 1. The public right of way over land situated at Rushywood Farm, Haselbury Plucknett and shown by a continuous black line on the map attached to this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 14 days from the date of confirmation of this Order.
- 2. There shall at the end of 14 days from the date of confirmation of this Order be a public footpath over the land situated at Rushywood Farm, Haselbury Plucknett as described in Part 2 of the Schedule and shown by a broken black line on the map attached to this Order.
- 3. This Order shall be known as the South Somerset District Council, Public Footpath Y11/8 (Rushywood Farm) Public Path Diversion Order 2019

## <u>Description of site of existing footpath path (L-M-N-R-S-T as indicated on the map)</u> <u>Path to be extinguished</u>

The whole width of that part of **Public Footpath Y11/8** commencing at Grid Reference ST 46549 12716 (**Point L**) and running in a generally northerly direction for a distance of approximately 333 metres to Grid Reference ST 46517 12046 (**Point M**), then arcing easterly for a distance of a distance of approximately 42 metres to Grid Reference ST 46557 12058 (**Point N**) before running eastwards for approximately 142 metres to Grid Reference ST 46696 12080 (**Point R**), then north easterly a distance of approximately 151 metres to Grid Reference ST 46770 12911 (**Point S**) and finally running east for approximately 42 metres Grid Reference ST 46812 12917 (**Point T**)

## <u>Description of site of alternative footpath (L- T as indicated on the map)</u> Path to be created

Public Footpath, 2 metres wide commencing at Grid Reference ST 46549 12716 (**Point L**) and running in a generally north easterly direction across the field for a distance of approximately 566 metres to Grid Reference ST 46812 12917 (**Point T**)
