Freedom of Information Act 2000

Thank you for your request for information dated 22 September 2020 which the Council received by email. You have requested the following information:

Please provide copies of all correspondence including emails to and from internal consultees, consultee responses and copies of all neighbour objections for planning application 20/00158/FUL.

I am pleased to advise that the Council can provide some of the information you have requested on the attached documents. Please note some of the information has been redacted as it contains third party information. This information is exempt under section 40(2) of the Freedom of Information Act 2000 for the following reasons:-

It constitutes personal data of which the applicant is not the data subject. This exemption applies because you have made a request for information that comprises or contains personal data information about a third party. The Council has determined that the information relating to the third party should not be disclosed because disclosure would contravene one or more of the '7 key principles' that are set out under Article 5 of the General Data Protection Regulation (GDPR) which includes the principle that information should be 'processed lawfully, fairly and in a transparent manner in relation to individuals.' The term 'personal data' means data that relates to a living individual who can be identified.

Further documentation relating to the application is exempt for the following reasons:

Having carefully considered the matter, the Council has determined that some of the information is exempt from disclosure under the following provisions of the Freedom of Information Act 2000.

Section 21: information accessible to applicant by other means.
