The report I was referring to is an internal report for Cllr to agree our approach, a further report is being submitted to Cllr and Cllr next Wednesday detailing our Streetspace for London COVID-19 Transport recovery plan which will include details around schools streets. This has not been published yet and the schools we have prioritised have not been informed.

For now I think it would be best to say that Brent are proposing to introduce several temporary school streets with the hope that they will become a permanent arrangement. We will be using experimental TMO's to implement these and the process will include a 14 day consultation with stakeholders, emergency services etc., residents and businesses will be sent a notification letter to inform them of what is happening and the first 6 months of the experimental order will be treated as the consultation period.

Have you seen the new TFL guidance around school streets? If not you can find it here https://tfl.gov.uk/travel-information/improvements-and-projects/streetspace-for-london appendix 8.

We are planning to adopt their suggestion to use barriers etc. at first and then replace with CCTV if required (subject to funding).
