I do have a list of clubs, and would be happy to share these with you. Myself and [REDACTED] did discuss delivering a club consultation evening which I believe is needed. Before providing the above I do have huge concerns about the draft programme of use.

During previous conversations there was some discussion about the Rugby Club having some usage Sunday morning, which is something we were open to, however to have access to 2 key midweek evenings a week is not going to provide the level of community football access that is required.

In addition my understanding is that Newbury Ladies would require the facility from 13:00 on a Sunday.
