Hope you are well. I am not sure if you are the correct person for me to send this request to. As part of the Springfield Development Bungalow site, the appeal decision has recently been received in relation to the works to the access road. This required the applicant to apply for a road closure, which they have done.

The road closure confirmation is attached and shows the commencement date as 23rd March 2020. My request to you (or to be forwarded on to the correct person) is whether it is possible for the road to be closed earlier than this date. Every time the rain falls, we receive complaints regarding the road flooding and until they can undertake works in the highway to connect the drainage from within the site, these complaints are going to continue. The developer had hoped that the authorisation might be for January.
