## ROUNDTABLE EVENT: RECOVER, RENEW & TRANSFORM PROGRAMME FOR JUSTICE

As you will be aware the Scottish Government established a Recover, Renew, Transform programme for the justice system to recover essential services and transform how the system operates to ensure a resilient, effective justice system now and for the future.

Work under the programme continues, and I want to pay credit to the urgent, effective and collaborative work which has been undertaken in response to the pandemic. This includes the flexible and innovative responses to meet the operational challenges which COVID 19 presents, as well as the fundamental protection of rights and freedoms. I am also keen that we learn the lessons from the approach to date to inform both ongoing recovery and longer term transformation.

I welcomed the Lord President's decisive action of 11 January to amend the operation of court business, which balances the interests of justice with the very serious public health challenges presented by the new variant of Covid-19. It is crucial that we ensure our criminal justice system operates as safely and effectively as possible during these unprecedented times.

I am committed to continue working with justice organisations, the legal profession and the third sector, to consider all options to respond to the inevitable increase in cases awaiting trial, as well as the wider impact of the on-going public health challenges across the justice system.

I would also like to take this time to consider options for practical and achievable solutions to address the ongoing challenges to the system including the current backlog of cases, ensuring that the system is operating sustainably, effectively and building resilience.

Building on the budget statement on Thursday, and my recent letter of response to the Justice Committee, the Criminal Justice Board will produce a paper to support these discussions. This will be circulated in advance.
