Please find attached to this response 3 attachments of redacted emails relating to your request. Where possible earlier thread emails have been removed as have all emails covered by legal privilege such as those relating to discussions about the proposed section 106 agreement. The Council has redacted the names of junior officers to initial and surname and completely removed the names of employees of external organisation and their direct contact details. You will also note your personal details have been redacted along with other local residents. This is a public FOI disclosure and it would have been a breach of data protection legislation to allow residents names to be released into the public domain as part of and very public FOI response available on the whatdotheyknow website.





In addition, no attachments have been provided mainly because of the sizes of the disclosure document in 3 parts already and the additional time it would have taken council staff. Should you believe an attachment adds to the public disclosure please advise and the Council will extract a copy and consider it for release or advise you it is exempt.

Please be advised the Council has exceed the appropriate limit and fees regulations preparing this response (over 30 hours in total) and will not therefore provide any further emails covering extended time periods relating to Lancaster Way unless that time is paid for via a fees notice.

If you consider the Council has not provided the information you have requested, you have the right to challenge that decision in respect of your information request within 6 months.
