Dear Cllr Young

I am aware of the situation as I have tweeted with some people over the weekend. The funding has been transferred to ECC and currently we are working to have it added to the capital programme.

I apologise for not keeping you informed and I was supposed to contact you with an update and process last month.

The next steps will be as follows:

- Add the funding to the capital programme within Highways (this should be done at the beginning December)
- Complete and agree a project mandate and brief with the delivery team
- Agree dates for the final design and construction (currently this is looking more likely at a 2013 delivery for both the design and construction)
- Complete the design so that the consultation can begin and land purchased (this may take some time and we will need to identify additional funding sources for the land purchase)

I'll endeavour to get some preliminary design and construction dates to you shortly after speaking to the design and programming teams.

I note that construction work has already started on the new University car park, although not on the linked cycle path between Wivenhoe and the University. The planning application was passed under the strict condition: "Consideration of the application be deferred for completion of a legally binding agreement to provide for a contribution of £250,000 to be secured that would be used to help fund the proposed University of Essex to Wivenhoe cycling and walking route."
