Hi Lesley

As mentioned earlier, I can confirm that I have searched my private email account and I hold no official information in that account for the period covered by the request.

I do think there is an issue abut this request being potentially vexatious, the focus being private emails, not specific information. It's a combination of a fishing expedition and a test of whether we can comply with our own guidance. I guess that's just about legitimate if there are no other factors present which would suggest the request was vexatious.

We are dealing with a number of section 50 complaints following similar requests from journalists to government departments. The key issue, which is addressed in our recently published guidance, is not whether any official information is held on private email accounts, but whether information is held there on behalf of the employing public authority. For example if private, unofficial channels of communication have been used instead of the official channels. So, for example, if an email received on the ICO system (eg a

newsletter from another DPA or a training organisation) was simply forwarded to a private email address for information it would not be held for the purposes of FOI if it were retained on an ICO system.

I hope this is helpful.
