Thanks for your email.

I haven't agreed to its use, rather Sarah and I discussed its use during our site meeting towards the end of last year and we left it that Sarah would draw something up for my consideration – we spoke about the possibility of having a raised table at the Queen Street/Culver Street East junction. However, as part of the overall Queen Street/St. Botolph's Street public realm improvements, it's likely a 25mm upstand kerb rather than a full height kerb would be used and therefore it's not possible to introduce a raised table at the above location.

Good to hear from you, and encouraging that the authority is content with the principle of the proposals notwithstanding the usual finessing necessary to take this through technical approval and a finalised s278 legal agreement in due course.

As commencing the development itself is not contingent on the s278 works being delivered (plus the move away from pre-commencement conditions over recent years) it would be preferable to secure implementation of these works through a pre-occupation condition in the usual way. We would then have time within the programme to take these proposals from the current concept stage, through to detail and technical approval, through the relevant formal channels at the authority, without unnecessarily delaying any of the non-dependent build elements.

I hope this email finds you well.

I have discussed at length your latest submission regarding Queen Street with a colleague who would oversee implementation of the works under a S278 agreement and we still have some concerns which we'd like to discuss with you as soon as possible.

We think there is a way forward in terms of there being a deliverable scheme however I think time is running out in terms of the planning application being considered by committee and therefore would you be comfortable with a pre-commencement planning condition, which would require the details of a public realm scheme similar to that shown to date to be submitted to and agreed in writing by the Local Planning Authority prior to commencement of the development, with the development being completed in accordance with the agreed details to the satisfaction of the Local Planning Authority prior to occupation of the development.
