Re: [REDACTED] Southport, PR8 [REDACTED]

I have recently been contacted by my above constituent regarding his concern that he is unable to rent out his property through Liverpool City Council or Cobalt Housing.

[REDACTED] is the owner of [REDACTED] Liverpool, L11 [REDACTED] where he resided until 2010. Unfortunately, he and his family were the victims of racial abuse and antisocial behaviour and he was forced to leave the property. He has since rented out the property privately but would now like to offer the property to Serco to use in their efforts to house asylum seekers, but has thus far been unsuccessful due to the high levels of antisocial behaviour in the area.

When Serco were refused the necessary licence by Liverpool City Council [REDACTED] offered the property to their Housing Department, at a social rent, however for reasons that are unclear this offer was not taken. [REDACTED] similarly offered the property to Cobalt Housing and the offer has also been refused.

I would therefore be grateful if you could inform me as to whether you are aware of any initiatives that [REDACTED] might take advantage of, as he would very much like to offer his home for a social rate rent to those most in need.
