Thanks for your reply.

Even if a PI is not held, I cannot see how you will be able to draw down £3m in 18/19.

In that scenario, you will be submitting the final business case on 25th January 2019. Allowing 8 weeks from then before a decision is announced takes us to 22nd March. In practical terms, based on several years' experience, that will almost certainly be too late for me to account for it in 18/19. The practicalities of issuing a grant offer, receiving acceptance and arranging payment will take longer than the period available before the accounting "cut off" point towards the end of March. And that's assuming everything could happen without any delays at all.

I can't accrue for spend in 18/19 retrospectively. It will need to be accrued in 19/20.

Please can you review your profile in the light of this.

Hi xxxxxxxx,

We have been given a date for a PI by the DfT casework team (30 October 2018).

However, they have stated that if all statutory objections are removed before that time a PI will not be held.

We had seven statutory objections to the CPO / SRO. Two have now been removed and we have an undertaking that a third objection (Network Rail) will be withdrawn shortly.

This will leave four landowner objections – we have now reached agreement regarding acquisition terms with three of these four landowners and when legal deals are signed this will be on the basis the objections are removed. We are working to conclude matters with the fourth.

We are forecasting spend of £3m this year so assume that if BC is signed off by end of the financial we could draw down funding to cover that capital expenditure.
