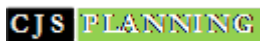
Thank you for confirming the details of the presentation. I will coordinate with Provectus and come back to you in the near future regarding the details of the presentation.

Proposed Surface Mining of Coal on Land west off the A61, Hill Top Farm, Clay Cross, Monday 19 March 2012, 3.30, Committee Room 1, Derbyshire County Council.

You have confirmed that you would like to present your proposals to the County Council's Local Members; so they are given the first opportunity to understand the details, potential impacts and the benefits the scheme may have on the local community and environment. The County Council is moving towards a Development Management approach in dealing with planning applications; in particular for those schemes that are major and complex.
