The A61 at this location is subject to a 50mph speed limit and any access for the proposals will need to demonstrate exit visibility splays and forward visibility in the region of 160m.

The existing layby on the eastern side of the A61 forms part of the adopted highway and its use as a HGV holding area is unlikely to be acceptable - this should be provided within the site.

With no details on the scale of traffic movements on the site I am unable to determine the most appropriate form of access into the site - any formal application will need to be supported by a Transport Assessment and guidance on the scoping for this can be provided by this Authority's Transportation team.

You will appreciate these brief comments represent the informal views of the HIghway Authority based on the limited information provided, may not be fully exhaustive and are given without prejudice. I have copied this email to David Arnold in Planning to keep him informed.
