## FREEDOM OF INFORMATION REQUEST

Thank you for your Freedom of Information request submitted to Highways England on the 25<sup>th</sup> of April 2016 regarding the new Highways England Offices at Sherwood Park, Nottinghamshire.

A copy of the information, including your original questions in *italics*, is shown below.

1. Please provide me with the full cost from design, commissioning, build and delivery of the new HECL offices at Sherwood Park Nottinghamshire.

The costs for the delivery reflect the condition of the building which included the requirement to install a new heating and cooling system. It also includes a network control centre which operates 24/7. The original condition of the building and the level of works required are reflected in the rental level agreed with the Landlord, which also include a 26 month rent free period worth around £520,000.

The overall fit out costs including professional fees total £2,948,461.00 plus VAT and this can be broken down as follows:

Mechanical & Electrical Design, Project Management, Quantity Survey, Principal Designer, Structural Engineer & Asbestos survey: £191,576 plus VAT

Tim Flynn Architects: £104,000 plus VAT

Fit Out works (includes ICT structural cabling but excludes ICT hardware (desktops/printers/telephones etc, which are still in process of being installed): £2,652,885 plus VAT

2. Please also provide the total cost of employing the American designer to design the project.





We have used the Tim Flynn Architects whose costs are detailed above to design the fit out. They are based in London and have a number of different Nationalities working for them.
