FREEDOM OF INFORMATION ACT 2000 - INFORMATION REQUEST

Thank you for your e-mail of 5th October 2010 in relation to the above.

Telent Technology Services Limited have provided the following information:

- * initial costs of each individual website
- ANSWER £10.5k for each website
 - * annual ongoing costs of each website since creation
- ANSWER £500 per year for each website
- * funding sources for each website, both for initial creation & ongoing maintenance
- ANSWER Funding for Mattisse (and therefore Help2Travel) is allocated to a budget identified as Network Information Management Systems (NIMS) by West Midlands Joint Committee and delegated to the West Midlands Planning and Transport Sub-committee. The total yearly allocation is known as the Local Transport Capital Settlement and is provided through specific grants under section 31 of the Local Government Finance Act 2003.

The majority of the Local Transport Capital Settlement is allocated to the West Midlands local authorities however a small proportion of the total allocation is managed centrally to cover strategic issues and NIMS is a small part of that centrally funded allocation.

In simple terms, part of the Local Transport Capital Settlement allocated to every West Midlands Local Authority is reserved to be used for strategic issues. Funding for the websites in question is met from that allocation.
