FREEDOM OF INFORMATION ACT 2000 – INFORMATION REQUEST

I am writing to confirm that we have now completed our search for the information you requested on 04/05/22. I wish to advise you that some information cannot be disclosed as exemptions apply.

A copy of the information that can be disclosed to you is shown below.

Please can you provide me with a list of dwellings for which you are currently charging a premium of council tax as they have been empty for more than 2 years?

Please provide the address of the dwelling and the level of premium you are charging.

584 properties registered under Long Term Empty Premium.

Where some of the information has been withheld because an exemption(s) applies, I have described the exemption and reason below.

The exemption(s) applied: Section 31 – Law Enforcement

This applies because:

Section 31(1)(a) relates to the prevention or detection of crime. It is the Council's view that the empty property address information requested, if disclosed to the public domain, could lead to crime and potential anti-social behaviour. This would then cause strain on Blackpool Council, local policing, or cause distress within the local community.

Section 31 is a qualified exemption and therefore a public interest test is required. The information requested has not been provided because the public and local communities surrounding any such empty residential properties would expect the Council to prevent possible anti-social behaviour/crime on these empty properties. Blackpool Council does not publish a list of empty residential properties for this

reason. It is therefore the Council's opinion that the public interest in maintaining the exemption outweighs the public interest in disclosure.
