## Request

These questions all relate to the Covid-19 local authority Discretionary Business grants Announced by the government in May 2020 to help businesses which fell outside the small business rates grant scheme.

I am requesting the following information:-

- 1. How much in funds has East Suffolk council received from the Government for the Discretionary grants?
- 2. How many applications have you received for this fund in total?
- 3. How many applications have been processed to the 14.8.2020 (closing date)
- 4. How many applications have been successful?
- 5. How many claims have been rejected and what were the reasons given to the applicant.
- 6. Within rejected application numbers, how many applications that had fixed costs and showed there was a clear and dramatic drop in business due to the Covid-19 pandemic were declined and the subsequent reasons for the decline.
- 7. How much of the funds have been paid to successful applicants?
- 8. What is the average discretionary grant awarded?
- 9. What is the business type breakdown of the grants awarded both within the A-F business types eligible to apply and the actual type of businesses within each type of business.
- 10. How much of the fund was remaining unallocated as of 14.8.20 The closing date for applications.
- 11. The names and job descriptions of the panel that made panel decisions.

- 12. The Full and Detailed criteria used to approve or decline individual applications.
- 13. How many grants were declined on the basis that the panel made incorrect assumptions about a business and how many of these businesses did not accept the declined status of the application and requested it be reviewed.
- 14. How many of group A shared premises applications were decided by a panel, and how many of these were accepted and how many declined and the reasons for those declines.
