Highways Act 1980 Section 26

CARMARTHENSHIRE COUNTY COUNCIL
(PANNAU-GLEISION FARM, ESGAIRDAWE, CARMARTHENSHIRE)
PUBLIC PATH CREATION ORDER 2014

This order is made by Carmarthenshire County Council ('the Council') under section 26 of the Highways Act 1980 ('the 1980 Act') because it appears to the Council that, having regard to the matters set out in section 26(1), there is need for a public bridleway over the land to which this Order relates, and that it is expedient that the bridleway should be created.

Cynwyl Gaeo Community Council has been consulted as required by section 26(3) of the 1980 Act.

BY THIS ORDER:

1. There shall be from the date of confirmation of this Order a public bridleway over land situated between Pannau-gleision Farm and registered public bridleway 7/23 in the County of Carmarthenshire as described in Part 1 of the schedule to this order and shown by a bold broken line on the Map attached to this order.

SCHEDULE

PART 1

DESCRIPTION OF LAND

A strip of land being ^{two and a half (2.5) metres} ~~approximately~~ Two (2) Metres in width and Four Hundred and Three (403) Metres in length which shall commence from the terminus of Unclassified Road U4070 at Pannau-gleision Farm situated at Esgairdawe, Llandeilo being Point 'A' on the Map annexed to this order ('the Map') and which proceeds in a Southerly direction along a hardcore track and through a field gate (at Point 'B' on the Map) before turning in an Easterly direction to follow an old lane along a field edge. The route then passes through a field gateway crossed by a narrow and shallow watercourse located at (Point 'C' on the Map), before continuing along the lane in an Easterly direction to meet registered public bridleway 7/23 via a field gate (being Point 'D' on the Map).

Length: 403 metres

Width: 2.5 metres
