PUBLIC PATH CREATION ORDER 2014

On the 20th August 2014, an Inspector
 appointed by the Welsh Ministers confirmed with
 changes, the above Order made under Section 26
 of the Highways Act 1980.

The effect of the Order as confirmed is to create a
 bridleway between Pannau-gleision Farm and
 existing bridleway 7/23; as shown on the order
 map.

A copy of the Order as confirmed and the order
 map have been placed and may be seen free of
 charge at the Countryside Recreation Unit,
 Mynydd Mawr Woodland Park, Tumble, Llanelli,
 from 9.00 a.m. to 4.30 p.m. on any weekday.
 Copies of the Order and map may be bought
 there at a price of 50 pence. Postal copies may
 also be obtained at a price of £5.00.

Any person who wishes to claim compensation
 under Section 28 (as applied by Section 121 (2) of
 the 1980 Act for depreciation or damage for dis-
 turbance arising as a result of the coming into
 force of the Order must make a claim in writing
 to Mr Ian Jones, Head of Leisure & Recreation,
 Regeneration & Leisure Department, Mynydd
 Mawr Woodland Park, Tumble, Llanelli, Carm.
 SA14 6HU, and serve it by delivering it at, or
 sending it by pre-paid post to that address not
 later than 23rd January 2015.

The Order came into force on the 20th August
 2014, but if a person aggrieved by the Order
 wants to question its validity, or that any
 provision contained in it, on the ground that it is
 not within the powers of the Highways Act 1980,
 as amended, or on the grounds that any
 requirements of the Act, as amended, or of any
 regulation made under the Act has not been
 complied with in relation to the Order, he or she
 may, under Paragraph 2 of Schedule 2 to the Act
 as applied by Paragraph 5 of Schedule 6 of the
 Act, within 6 weeks from 10th September 2014,
 make an application to the High Court.
